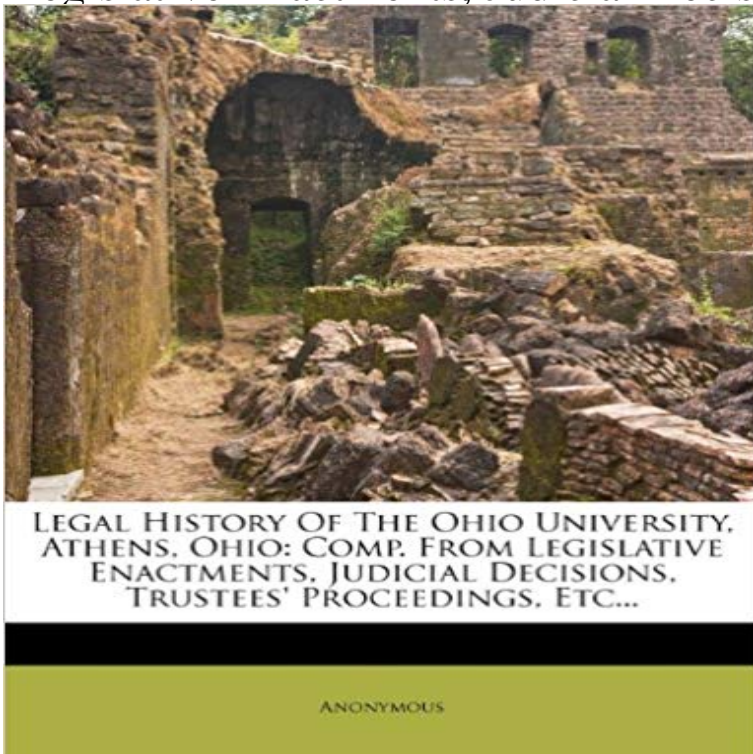


Legal History of the Ohio University, Athens, Ohio: Comp. from Legislative Enactments, Judicial Decisions, Trustees Proceedings, Etc...
