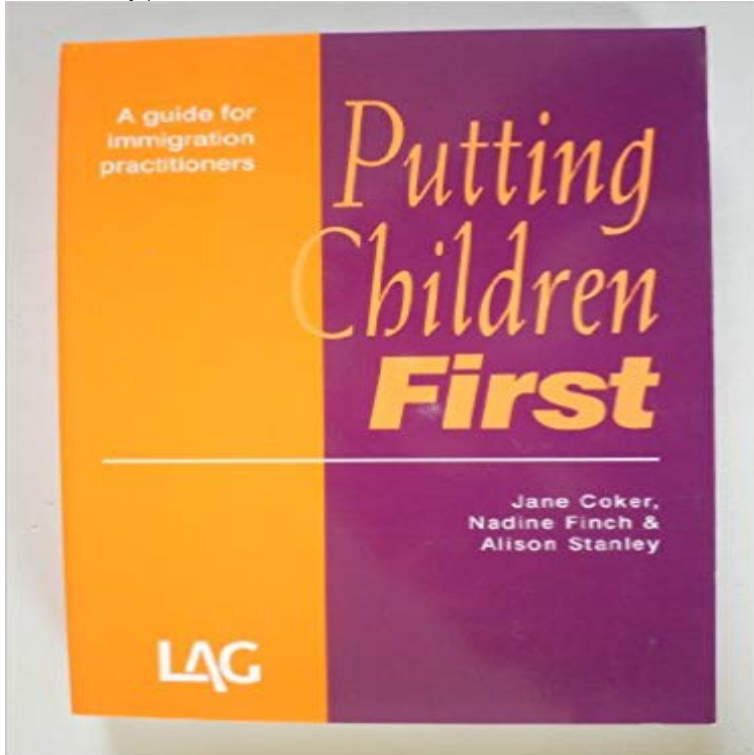


Putting Children First: A Guide for Immigration Practitioners
