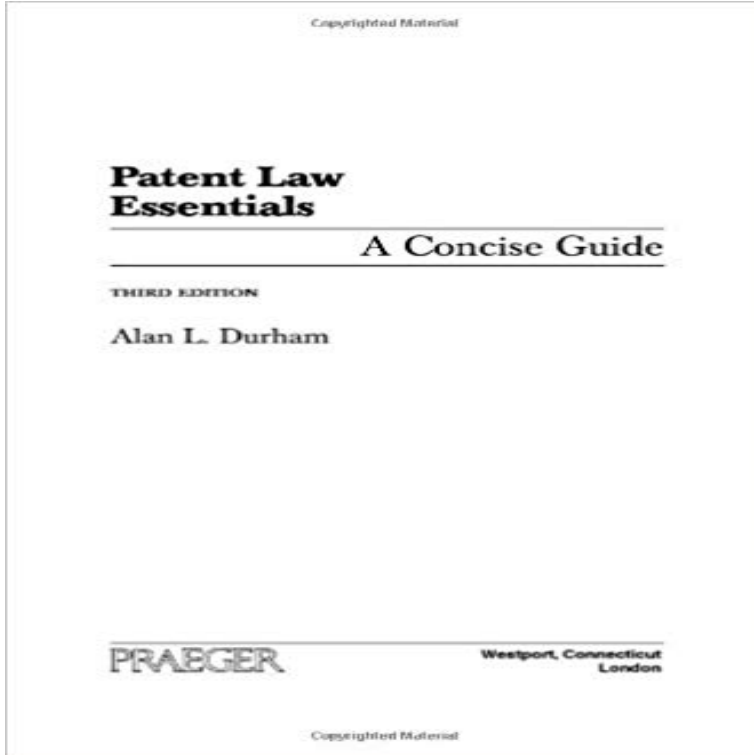


Patent Law Essentials: A Concise Guide, 3rd Edition

The revised and updated Third Edition discusses recent developments in the law and draws from the most current case authority. For example, it covers the apparent court backtracking on the patentability of business practices and what that means for both businesses and inventors. It also covers the Supreme Court's review of the obviousness standard, the changing standards for willful infringement, the reexamination by the Federal Circuit Court of Appeals of the protocols for interpreting patent claims, and the potential for patent law reforms in the next few years. Used as an introduction to the topic or a handy desk reference, this book will be an indispensable guide to the dynamics and mechanics of patent law. Durham illustrates complex legal issues through dozens of in-depth examples, many borrowed from actual cases. Of particular interest are cases involving patent disputes over computer software and biological materials. From building a better
